I. CRISIS IN THE WORLD OF THOUGHT 102

i. The Problem of Church and State: the permanent legacy of the reign of Philip the Fair—in what sense is the pope Lord of the World?—the view of the thirteenth-century canonists—Innocent IV—Hostiensis—*Unam Sanctam*—influence of St. Thomas's theory about Scripture as an argument—the polemicists of 1294-1303—Giles of Rome—James of Viterbo—the royal jurists—John of Paris—anonymous writings—Dante—modern views.

ii. The Problem of Faith and Reason: the synthesis of St. Thomas not universally accepted—ultimate significance of this—what St. Thomas achieved—the Oxford Franciscan school of philosophy—Roger Bacon—John Duns Scotus—his theory of knowledge—role in his thought of the idea of God's infinity—and of the Divine Will—influence of his theology on later spirituality—William of Ockham—in reaction against Scotus, but radical critic of Thomist synthesis—his Nominalism dissolves the reality of philosophy—theory of God's omnipotence and will—a root of Lutheranism—the Avignon judgment on Ockham—his thought colours the Catholic mind until the Reformation—despite condemnations it captures the university world, as the *via moderna*—stagnation of the older schools of thought.

II. THE TROUBLED TIMES OF JOHN XXII 125

i. The Friars Minor: Holy See vacant two years (1314-1316)—character of John XXII—the Franciscan controversies about the meaning of the rule, 1226-1314—John XXII suppresses the "Spirituals"—remodels the order—by deciding (against the order) that it must, in practice, follow ordinary religious poverty—and by declaring heretical its theory that Our Lord had no rights of ownership—revolt of the Minister-General and Ockham—their flight to Lewis of Bavaria.

ii. The last War with the Empire, 1314-1356: The last of these great struggles—its character and significant ending—John XXII and the double imperial election of 1314—his refusal to recognise the right of the victorious Lewis of Bavaria—Lewis, excommunicated, invades Italy—the *Defensor Pacis*—Lewis "deposes" John for heresy—names a Franciscan anti-pope—Lewis's victory peters out—The peace policy of Benedict XII—effect of this war on Catholicism in Germany—Clement VI supports claim of Charles of Luxemburg to the empire—Charles elected—by the Golden Bull he terminates papacy's intervention in imperial elections—Innocent VI tacitly accepts the *fait accompli*.

iii. *Marsiglio of Padua*: importance of his work—his life—varied sources of his ideas—his aim the destruction of Catholicism as a social power—examination of his theories—on the State—on the Church and its relation to the State—glorification of State as “totalitarian”—the condemnations of Marsiglio—which his theories survive—their later wide influence—feeble Catholic replies to them.

iv. *The End of John XXII*: the pope’s novel theory about the state of souls immediately after death—he is attacked as a heretic by the rebel Franciscans—defended by Jacques Fournier—who, however, corrects his error—John’s deathbed explanation and submission—Benedict XII defines the doctrine.

III. THE AVIGNON RÉGIME 155

i. *The centralised administration*: new stability of the curia—the age of the Canon Law—the chief papal offices—and tribunals—the Canon Law—role of the papal treasury—the taxes levied on the universal church—system of collectors—the amount of the revenue—the ever-recurring financial crises—the final quasi-bankruptcy—where the money went—the discontent the system caused—English opposition—the anti-papal laws of Edward III and Richard II—their permanent significance—resistance in Germany—original motive of system of papal provisions—the abuses which in the end were inseparable from it—the “state-of-the-church” problem now chronic—where the papal reformers failed.

ii. *The Popes, 1334–1362*: Benedict XII—reforms in the papal court—and curial offices—of the Cistercians—Benedictines—Austin Canons—Friars Minor—Dominicans—Clement VI—worldliness returns—the Black Death—Innocent VI—the first conclave “capitulation”—new attempts at reform of the curia—Avignon at the mercy of the Free Companies.

CHAPTER III. THE RETURN OF ST. PETER TO ROME, 1362–1420

I. INFELIX ITALIA, 1305–1367 188

The problem how to maintain papal independence—Disastrous wars of Clement V against Venice—of John XXII against the Visconti—of Clement VI against Florence—Gil Albornoz, conqueror and statesman.

II. THE POPES LEAVE AVIGNON, 1362–1378 198

Character of Bl. Urban V—despite general opposition in the curia he returns to Rome—his death at Avignon—Gregory XI—influence of St. Bridget of Sweden on him—and of St. Catherine of Siena—the pope’s worldliness and nepotism—the great revolt of the Papal States—war against Florence—Gregory XI returns to Rome—his death.

III. CHRISTIAN LIFE, MYSTICS, THINKERS 208

The Saints, 1270-1378—the *vie dévote* among the laity under the influence of the Friars—the literature produced for it—the *Devotio Moderna*—its one weakness—in reaction against the “speculative” Dominican mysticism, Eckhart, Tauler, Suso—the *Devotio Moderna* and learning—the *Via Moderna* in philosophy and theology—Nicholas of Autrecourt—Peter d’Ailly—Gerson—the new non-Aristotelian Physics—Nicholas d’Oresme—the new German universities.

IV. THE SCHISM OF THE WEST, 1378-1409 229

i. *The Two Conclaves of 1378*: election of Urban VI—discontent of cardinals with the new pope—they leave Rome—and elect Clement VII at Fondi—war between the rivals—Clement VII, defeated, retires to Avignon.

ii. *Discord in each “Obedience”, 1379-1394*: St. Catherine and the “Clementines”—her death—Urban instals new King of Naples—Clement also—French invasion of Naples—it is defeated—Strife between Urban and his new cardinals—five cardinals “disappear”—Urban VI a wanderer—his death—the French scheme to control Italy through Clement VII—role and spirit of the University of Paris—renewed French invasion of Naples—the French demand for a second principality in Italy—Clement refuses—new initiative from University of Paris—its suggestion of neutrality—Clement’s resistance—death.

iii. *Benedict XIII’s Quarrels with the French, 1394-1403*: character of Benedict XIII—beginnings of a schism within the schism—Benedict’s stand for the tradition that pope has no superior but God—his obstinacy and duplicity—the French crown and the University of Paris combine to check him—National Council of Paris, 1398—decision to “withdraw” obedience from Benedict—character of the majority—the régime of a Church without the pope, 1398-1403—Benedict’s cardinals besiege him at Avignon—he becomes the French king’s prisoner, 1398—his escape, 1403—the French again acknowledge him as pope.

iv. *The Roman Popes, 1389-1406*: Difficulties of Boniface IX with the Emperor Wenzel—and with Rupert, his rival—war in Germany and Italy—Boniface compelled to recognise Rupert unconditionally—financial plight of Boniface—simony one way out—gross money scandals in granting Indulgences—mission of Benedict XIII to Boniface—Boniface’s sudden death—Intrigues of Benedict to discredit the new Roman pope, Innocent VII—they are exposed, and cost Benedict his hold on France—National Council of Paris, 1406—election at Rome of Gregory XII pledged to end schism by abdication.

v. *Benedict XIII and Gregory XII, 1406-1409*: Benedict's shifty acceptance of Gregory's plan—Gregory changes his mind—the negotiations about where they shall meet—Gregory's intrigues with Naples—he plans to create more cardinals—his old cardinals revolt—and escape to Pisa—meeting with Benedict's cardinals—France finally abandons Benedict—who calls a General Council—union of the cardinals of both the rivals—they summon a General Council—so does Gregory—Benedict's council at Perpignan—Gregory deserted almost by all.

V. THE CHURCH UNDER THE COUNCILS, 1409-1418 . 270

i. *Pisa*: German protest against the Council—Failure of Gregory XII's negotiations—trial and deposition of Gregory, and of Benedict XIII—election of Alexander V—Gregory XII's Council at Cividale—his flight to Gaeta—Alexander's armies take Rome—his death—election of John XXIII—Naples acknowledges him—John's Roman Council of 1412-1413—the Reform party active—John XXIII, driven from Rome, appeals to the Emperor—who forces him to summon the Council of Constance.

ii. *Constance*: enduring importance of this council—three main tasks before it—the procedure adopted of voting by "nations"—John XXIII pledges himself to abdicate—but then absconds—the revolutionary anti-papal decrees which follow upon this—John captured—his trial and deposition—Gregory XII re-convokes the Council, and abdicates to it as convoked by himself—negotiations with Benedict XIII for his abdication—he refuses—the Spaniards abandon his cause—the Council divided on how to elect the new pope and on reform measures—general deadlock—the English solve the crisis—election of Martin V—the reforms enacted—the concordats of the Council.

CHAPTER IV. FIFTY CRITICAL YEARS, 1420-1471

I. THE MENACE OF HERESY AND SCHISM, 1420-1449 . 306

The restored papacy handicapped—the débâcle in Bohemia—Wyclif's career and significance—John Hus—the Czech revolt and the crusade of Martin V—the poisonous legacy of Constance—Martin V's action against it—Council of Pavia-Siena—Martin V as a reformer—Eugene IV elected pope—Council of Basel opens—its first misunderstanding with the pope—its negotiations with the Hussites—the council's struggle to dominate the papacy—its reform decrees—the deadlock—Eugene IV negotiates with the Greeks for reunion—transfers the council to Ferrara—a minority resists—and "suspends" the pope—it gains support in France and Germany—the Pragmatic Sanction of Bourges—the pope "deposed" at Basel and "Felix V" elected—the Catholic princes use the new schism to bully the pope—the submission of Germany to Eugene IV—the schism ends under Nicholas V—the mission of Nicholas of Cusa to Germany.

II. THE RETURN OF ISLAM, 1291-1481 342

The anarchy in the East after the last crusades had failed—the new Ottoman power—the lack of unity among the Christians—efforts of the popes to unite the West—it remains disinterested in Eugene IV's great scheme—the re-union council of Ferrara-Florence—its definition that the papal primacy is divinely instituted—re-union of the lesser churches of the East—the last stages of the Ottoman conquest—fall of Constantinople—the Catholic heroes Hunyadi and St. John Capistran, Skanderbeg—the last crusading popes Calixtus III and Pius II—their failure—the Turks in Italy.

III. THE RETURN OF THE ANCIENT WORLD 361

Early days of the literary revival—it coincides with a time of philosophical decadence—the Avignon popes its earliest patrons—their library—Petrarch—the humanists of the papal curia—their role in the Renaissance—their effect on the tone of the papal court—the popes as patrons of the arts—Nicholas V's great reign—paganism reviving—the new philosophical studies—Plato—Aristotle—damaging to prestige of theology—the new cult of Nature—the attack on Christian asceticism—the dissolution of morality—Humanists as political conspirators.

CHAPTER V. “*FACILIS DESCENSUS . . .*”, 1471-1517

I. A PAPACY OF PRINCES 386

Sixtus IV—his numerous kinsmen promoted as instruments of a new temporal policy—Count Girolamo Riario dominates the reign—his share in the Pazzi murders—the pope at war with Florence—which appeals to France and to a General Council—the war ended by the diplomacy of Lorenzo de' Medici—Girolamo brings off a new war, against Naples—then against Venice—death of Sixtus IV—Rome at his death—the Conclave of 1484 a new type.

Innocent VIII—new war with Naples—the pope's submission—his league with the Medici—the pope's use of his children as instruments of policy—their marriages to princes—scandal of the forged bulls—general corruption of the curial administration.

Alexander VI—the policy strengthened of governing through relatives—the pope's family—the enmity of Cardinal Giuliano della Rovere—the French invasion of Italy begins a new age—Alexander's war with the Roman barons who had supported the French—new scandals in the pope's family—Lucrezia—the Duke of Gandia—Cesare Borgia now dominates the reign—the Papal State made over to the pope's family—the Franco-Spanish pact to divide Naples—the new wars—and scandals—sudden death of Alexander VI.

Julius II—the two conclaves of 1503—Giuliano della Rovere gets the better of Cesare—is elected pope as Julius II—his critical position as temporal ruler—he rids Italy of Cesare—prepares to recover territories from Venice—takes the field personally against Perugia and Bologna—the papacy enters European politics—the League of Cambrai—Venice, defeated, yields to the pope—Julius prepares war against France—the French retaliate by fomenting a schism—four cardinals desert the pope—the emperor joins with France—Council of Pisa called to “depose” the pope—crisis of the reign—Julius summons the (5th) Lateran Council—the council at Pisa a farce—French military disaster—Julius’s share of the captured territories—he now turns against Venice—which calls in the French—new war beginning, when Julius II dies.

Leo X—an unexpected choice—the new papal policy of systematic duplicity—the French defeated—they submit to the pope and the Lateran Council—incompetence of Leo’s advisers—French conquest of Milan, pope at their mercy—loses conquests of Julius II—but secures Florence for his own family—the Concordat with France—the war with his own rebels—the new worldliness of the papal court—where all is pleasure and extravagance—the cardinals’ plot to murder the pope—Leo X and the election of Charles V as emperor—the new war as Charles’s ally against France—Leo’s sudden death.

II. CHRISTIAN LIFE AND THOUGHT, 1471–1517 . . . 435

State Absolutism: the chief feature of the age—the great empires of modern Europe now appear—personal mediocrity of the popes as a quasi-permanent weakness—the popes poorly supported by the episcopate in the later Middle Ages—which is largely controlled by princes and great families—absentee bishops—pluralists—minors appointed—the popes surrender wide rights of nomination—the new Spanish Inquisition, as a surrender of jurisdiction—the French Concordat of 1516 also—the new determination of the Catholic princes to master the papal action—the popes as reformers, 1471–1511—Leo X divides the Friars Minor into two independent orders.

Catholic Thought: the decline continues—Gerson—Nicolas of Cusa—Gabriel Biel—heyday of Voluntarism and the *probabile*—effect on belief in Original Sin, on theories of Grace and human liberty—the *Utopia*—Machiavelli’s *Prince*—Erasmus—Cajetan and the renaissance of the thought of St. Thomas.

The General Council of the Lateran, 1512–1517: its condemnation of Averroism—its reform decrees—decline of the system of provincial synods—the conflict of bishops and mendicant orders.

Christian Life: Saints and Beati—the new world of finance and capitalism—St. Antonino, pioneer of social theology—the bankers and the papacy—role of the new bourgeoisie—the ordinary man’s religious life—the protests against abuses—Savonarola.

III. LUTHER	497
-----------------------	-----

The time and place that bred him—Germany at the eleventh hour of the Middle Ages—Indulgences, the doctrine and practice—the scandalous circumstances of the indulgence of 1516: the money, the erroneous teaching—Luther's life and temperament, 1483–1517—his new theology, its occasion and sources—and logical consequences—the first conflicts, i.e. before the Indulgence affair—Luther's theory creates a new world inevitably destructive of traditional Christianity—Luther's special appeal to Germany—the theory in the three great pamphlets of 1520—Luther denies the rights of reason in religion and morals—the Bible the sole source here of a Christian's knowledge—whence an erroneous theory of the State—and of Law—the divine right of the State and of the *fait accompli*—Law divorced from morality, as piety is divorced from it in private life—theory of Church and State—religion has no rights as an external, organised thing—the State is, here, its divinely ordained master—double hold of the prince on the Church—the illusion of freedom—Luther's theory makes man the centre of religion—its pessimism—morbidly—it is not a solution to the problem of the age but a surrender to despair—and the full development of medieval decadence.
